ARRIVING PROCEDURES:

- **Master or designee may go ashore only to report the arrival to Master Harbor of La Amada Marina.**
- **No other person may leave or board the Vessel and no baggage or merchandise may be removed from it.**
- **The Vessel must be available for possible boarding at the time of the arrival report.**

PROHIBITED AND RESTRICTED ITEMS:

- **Firearms**
- **Food products**
- **Fruits and Vegetables**
- **Plants and Seeds**
- **Drugs and Narcotics**

For effects of the Customs Law, the import or export of prohibited merchandise is causal so that the customs authorities come to the precautionary distraint of said merchandised and of the means in which they are transported. Also, it constitutes an infraction related to the import or export of this type of merchandise and it is sanctioned with a fine: Therefore, these merchandises happen to be property of the Federal State, independently of the penal sanctions that the Penal Code establishes.

LA AMADA MARINA - MÉXICO**

Owner or Captain of the Vessel arriving to La Amada Marina facilities, has the option to authorize in writing to personnel of the Master Harbor (Miguel Ángel Pérez Chable) for the filling of all the paper works needed by the corresponding authorities in order to grant the legal permanence of the Vessel and its Occupants in Mexico.</p>	<p>US\$100.00</p>	<p>Owner or Captain / Miguel Perez (La Amada)</p>												
<p>2. Temporary import: The foreigners owners of Vessels, the Captain or through a legal representative, will have to make the temporary import of a single pleasure boat, sport of the type of boat, yacht or sailboat, longer than 4,5 meters of length, by means of the Temporary Permission of Import of Boat, in which under protest declares to say truth, that he commits himself to return in question boat within the authorized term and not to make acts or omissions that form infractions or crimes by the illegal use of the same one.</p>	<p>US\$50.00</p>	<p>Owner or Captain / Miguel Perez (La Amada)</p>												
<p>4. Once all the authorities granted the legal stay to the Vessel as well as to the crew, it must be needed to pay the Rights of Port.</p>	<p>From MX\$203.00 up to MX\$2,040.00, according to Vessels' tonnage.
